The platform is systematically organized into primary sections, each addressing core functions:

- Homepage: A dynamic space facilitating user engagement and direct access to different sections.
- About the Project: Offers an overview of the HealthyW8 initiative, including partner classifications based on expertise.
- **Platform Sections:** Comprehensive sections, such as Resources Library, Engagement, Interactive Tools, and Related Projects, each with distinct subsections containing diverse resource lists.
- **Contact:** Accessible from the homepage and featuring a form for user interaction, personal experience sharing, and links to social networking.

Crucially, the platform will continuously evolve as the project advances, introducing enhanced functionalities, multimedia content, videos, interactive questionnaires, and insights from ongoing clinical trials.



1. INTRODUCTION

1.1 Description of the document and pursue

This document serves as a comprehensive report detailing deliverable D6.2 "Launch of the OSP". It is crucial to recognize the inherent dynamism of the platform, prepared to evolve and receive regular updates over the entire duration of the project's lifecycle. This adaptability ensures its continued relevance and effectiveness in facilitating meaningful collaboration and information dissemination among stakeholders.

1.2 WPs and tasks related with the deliverable

Deliverable D6.2 is part of Work Package 6 "Communication, Dissemination, Training, Exploitation and Clustering (CDTEC) Activities" and directly related to Task 6.2 – Communication & dissemination materials & channels.

2. TECHNICAL ASPECTS

2.1 Website management tool

The platform has been developed using Drupal version 10.1.1. Drupal is an open-source content management system written in PHP and distributed under the GNU General Public License. This system has been selected due to its versatility and robustness in comparison with other content management systems.

2.2 Hosting and maintenance

The platform has been developed and will be maintained by the project partner KNEIA (www.kneia.com). The domain https://www.stakeholders.healthyw8.eu/ is hosted by the company RGNet in Spain. KNEIA is responsible for the update of the information on the website during the project.



2.3 Analytics

KNEIA will use Google Analytics GA4 to monitor the performance of the platform and to provide accurate, up-to-date information for the purpose of internal reporting to consortium members and external reporting to the European Commission. All indicators relevant to the platform will be measured on a monthly basis, including website activity such as session duration, pages per session and the bounce rate of individuals using the site, along with the information on the source of the traffic.

2.4 Personal data

Visitors can contact the project team with their names and personal e-mail, after having read and understood the privacy policy. No sensitive information will be collected from website visitors.

HealthyW8 will be adhering to all provisions detailed by the GDPR. In addition to following GDPR's principles, relevant national data protection legislation related to each project partner applies if they have access to the data.




Figure 1. Privacy Policy field on the OSP



3. PLATFORM CONTENT

The HealthyW8 Open Stakeholder Platform is available at: https://www.stakeholders.healthyw8.eu/

The platform aligns with the initial objectives outlined in the project Grant Agreement, seeking to facilitate the sharing of knowledge covering all the topics of the HealthyW8 Project approach and facilitate exchanges between the partners and all relevant stakeholders.

All pages include a header and a footer. On every page, the header includes the project logo and a menu to navigate the website.

The footer includes the EU funding acknowledgement and disclaimer, and links to the Privacy Policy and social media accounts.

3.1 The rationale behind the platform

The rationale of the platform encompasses a diverse set of communication tools dedicated to obesity research. This includes collaborative options such as interactive tools, social networks, and knowledge crowdsourcing. It also involves the dissemination of project results, such as databases, food ontology datasets, software products, clinical study results, and promotional materials like dissemination videos. The platform serves as communication support for workshops, meetings, and conferences.

Stakeholder integration is emphasized, utilizing a participatory design approach to involve all relevant stakeholders, improving cross-sectional ideas exchange for comprehensive obesity prevention strategies. The OSP acts as a knowledge system, integrating strategies and ideas from partners and stakeholders, thus enhancing the knowledge base through crowdsourcing knowledge, and promoting active stakeholder involvement.

The OSP will be regularly updated by introducing additional features to enhance interactive engagement. Specifically, future enhancements will incorporate consultation campaigns and integrated questionnaires, providing a structured channel for obtaining input and fostering meaningful interactions among stakeholders.



3.2 Structure

The HealthyW8 Open Stakeholder Platform (OSP) serves two primary purposes:

- Establishing a robust knowledge base and offering tools for information sharing.
- Facilitating stakeholder engagement and encouraging inter-sectoral dialogue.

Each of the described sections below addresses these core functions, employing diverse approaches tailored to the specific nature of their content.

3.2.1 Homepage

The OSP homepage has been designed as a dynamic space that will be modified according to the interests of the attracted stakeholders and the evolution of the project. The upper header includes the project logo, which is a permanent link to the homepage. From left to right, the main menu features the different platform sections are displayed.




Figure 2. Home page, upper header and main menu of the OSP

The homepage initiates with a welcome message, proceeded by an overview of the multi-stakeholder's goal.




Figure 3. Sections summary of the OSP

As you scroll down, for enhanced engagement, a visual menu comprised of boxes serve as a direct gateway for users to access the different sections of the platform (Figure 3).

Further down, the contact segment (Figure 4) provides a direct connection to the contact section.




Figure 6. Different platform sections as shown in the menu

The platform's structural layout ensures seamless navigation, with accessibility facilitated through the header menu or the designated boxes on the homepage's section summary (Figure 6).

- Discussion forums




Figure 8. Engagement

- o Food and diet






Figure 9. Interactive tools
